## Political Vendor Application Terms and Conditions

- 1. <u>Political Vendor Registration</u>: Each vendor must be registered for the event and will receive a packet containing booth assignments and a map prior to the event. Booth registrations are reviewed upon the receipt of a completed application and the vendor fee.
- 2. <u>Booth Rates</u>: Booth spaces are 12' x 12'. <u>Early Bird</u> cost per booth is \$55 (due July 25th, 2025). Cost after July 25th, 2025 \$75 <u>Set up requirements</u>: All booth spaces MUST be set up by 8:00 a.m. on Saturday, September 13th, 2025. Vehicles must be unloaded and moved outside the festival area <u>no later than 8:00 am</u>. You will need to supply ALL items necessary for your booth (i.e. tables, chairs, decorations, display panels, and any other associated items you may need.)
- 3. There is no electricity available. Your space is literally a 12' x 12' area marked off in the street.
- 4. <u>Festival Times</u>: The Festival begins at 9:00 am and is over at 4:00 pm. No booths may be taken down prior to 4:00 pm on Saturday, September 13<sup>th</sup>, 2025.
- 5. <u>Use of Space & Literature</u>: All demonstrations, interviews or sales activities must be conducted within the limits of your booth space. <u>Advertising and sales literature may be distributed from inside your booth only</u>. Presentations or sales outside your booth are prohibited! Exhibits must be contained in the designated 12' x 12' space. <u>NO beverages shall be distributed</u>. <u>Restrictions</u>: The Sapulpa Main Street Program reserves the right to restrict presentation or exhibits which may detract from the general character of the festival. The reservation includes person, things, conduct, printed material or anything which may be objectionable to the exhibits as a whole. In the event of such restrictions or eviction from the event, Sapulpa Main Street is not liable for any refunds.
- Failure to Show/Refund Policy: This is an outside event. There is no guarantee for the weather. NO REFUNDS WILL BE GIVEN. Any reserved space not occupied by the company by 8:00 am on Saturday, September 13th, 2025 will be forfeited without refund.

<u>Hold Harmless Clause</u>: "The exhibitor/vendor assumes the entire responsibility and liability for losses, damages and claims arising out of injury to persons or damage to displays, equipment, or other property brought upon the premises and agrees to indemnify, defend and hold harmless the Sapulpa Main Street Program and its owners, servants, agents, and any employees against all claims or expenses for such losses, including reasonable attorney's fees, arising out of the use of space at the festival. The exhibitor/vendor understands that the Sapulpa Main Street Program does not maintain insurance covering the exhibitor/vendors property or lost revenue and it is the sole responsibility or the exhibitor/vendor to obtain such insurance."
